# TOURNAMENT RULES AND REGULATIONS FOR 2006

1. PRIZE AND EXPENSE MONEY, PLUS COST OF BOWLING WILL BE SUBMITTED WITH ENTRY.
2. ENTRANTS WILL USE THEIR HIGHEST S.R.F.B.A. LEAGUE AVERAGE AS PUBLISHED IN THE FINAL AVERAGE BOOK FOR THE 2004-2005 SEASON. IF CURRENT 21 GAME AVERAGE AS OF FEBRUARY 1, 2006 IS TEN PINS OR MORE HIGHER THAN THE 2004-2005 SEASON AVERAGE, THE CURRENT AVERAGE MUST BE USED. IF NO AVERAGE WAS ESTABLISHED IN THE S.R.F.B.A. DURING THE 2004-2005 SEASON, USE THE HIGHEST CURRENT S.R.F.B.A. SANCTIONED AVERAGE, BASED ON 21 GAMES OR MORE AS OF FEBRUARY 1, 2006. ALL OTHERS WILL BOWL SCRATCH.
3. ENTRANTS MAY PARTICIPATE MORE THAN ONCE IN THE TEAM EVENT, SUBJECT TO U.S.B.C. RULE 317. NO MORE THAN THREE OF THE SAME MEMBERS CAN COMPETE TOGETHER MORE THAN ONCE. BOWLERS CAN PARTICIPATE IN DOUBLES MORE THAN ONCE WITH A DIFFERENT PARTNER AND MAY CASH ONLY ONCE IN SINGLES, HIGHEST SCORE BOWLED. THE FIRST SERIES ROLLED IN ANY EVENT WILL BE USED FOR ALL-EVENTS. NO DOUBLES ONLY OR SINGLES ONLY ACCEPTED. ENTRY IN BOTH EVENTS IS REQUIRED TO PARTICIPATE IN EITHER.
4. ALL-EVENT ENTRANTS PLEASE REFER TO U.S.B.C. RULE 307A
5. U.S.B.C. SANCTION CARD IS REQUIRED AND MUST BE PRESENTED. ALL MEMBERS OF S.R.F.B.A. ARE ELIGIBLE TO ENTER. NON-MEMBERS LIVING WITHIN THE JURISDICTION OF THIS ASSOCIATION WHO ARE NOT MEMBERS OF ANOTHER ASSOCIATION MAY ENTER BY PAYING AN AFFILIATE MEMBERSHIP FEE OF \$16.00.
6. THE PRIZE LIST FOR EACH TEAM DIVISION SHALL BE SEPARATE. PRIZE RATIO WILL BE 1 FOR 7 ENTRIES FOR TEAM, DOUBLES AND SINGLES. PRIZE RATIO WILL BE 1 FOR 14 ENTRIES FOR ALL-EVENTS.
7. BOWLERS WHO HAVE QUALIFIED FOR A PRIZE WORTH \$300 OR MORE IN CASH AND MERCHANDISE IN ANY EVENT IN A TOURNAMENT WITHIN THE PREVIOUS 12-MONTH PERIOD, MUST REPORT THE NAME OF EACH TOURNAMENT, THE ACTUAL SCORE, THE POSITION FINISHED, AND THE AMOUNT WON. SEE RULE 319D.
8. ALL BOWLERS ARE CAUTIONED TO BE FAMILIAR WITH THE RE-RATING REQUIREMENTS OF U.S.B.C. RULE 319E. ALL BOWLERS RE-RATED SHALL USE THE RE-RATED AVERAGE.
9. BOWLERS SHALL BOWL AS SCHEDULED UNLESS 24 HOURS NOTICE IS GIVEN THE TOURNAMENT MANAGER OF AN AGREED EXCHANGE.
10. ANY BOWLER WHO REPORTS A LOWER AVERAGE THAN REQUIRED, OR FAILS TO REPORT A PRIZE OF \$300 OR MORE FOR THE PREVIOUS 12 MONTHS, SHALL FORFEIT TOURNAMENT ENTRY FEES AND PRIZE WINNINGS.
11. FAILURE TO USE PROPER AVERAGE, OR MAKE A CORRECTION PRIOR TO COMPLETION OF THE FIRST GAME OF A SERIES, SHALL DISQUALIFY SCORE IF THE SUBMITTED AVERAGE IS LOWER THAN THE ACTUAL AVERAGE, OR BASE PRIZE WINNINGS ON SUBMITTED AVERAGE IF IT IS HIGHER.
12. ALL PRIZE MONEY WILL BE PAID ON A HANDICAP BASIS. CHAMPIONSHIP CHEVRONS AND TROPHIES WILL BE AWARDED TO FIRST PLACE WINNERS IN EACH EVENT FOR BOTH SCRATCH AND HANDICAP.
